

## Theme

The growing diversity and complexity of international migration present a need for reconceptualizing migration research. The aim of the 2019 IMISCOE Annual Conference is to facilitate exchanges in new concepts and innovative methodologies for understanding human migration in the 21st Century. We welcome proposals from various disciplines, such as political science, sociology, economics, history, law, anthropology, social work, public administration, demography, social geography, and others.

### Preferred proposals shall feature:

- i) State-of-the-art theories and concepts in migration research
- ii) Methodological innovations in migration studies
- iii) Advances in collecting and analyzing migration data

It is possible to submit individual paper proposals, panel proposals and workshop proposals (all sessions will each be assigned 90 minutes).

# CALL FOR PAPERS

## Understanding International Migration in the 21st Century: Conceptual and Methodological Approaches

### Individual Paper Proposals

Paper proposals should include a 250-word abstract and the name and affiliation of the author(s). Individual papers will be thematically clustered into panels. We strongly encourage authors to highlight the conceptual and methodological novelty of their contribution.

### Research Panel Proposals

Panel proposals should include a 250-word abstract of the theme of the panel, together with 3 or 4 thematically consistent and related 250-word paper abstracts. Submissions should also include the name and affiliation of the chair and a discussant, as well as the name and affiliation of the author(s) for each paper abstract.

### Workshop Proposals

Proposals can also be submitted for workshops, this can for example be book workshops, policy workshops or round tables, with the aim of discussing research or to outline future research agendas.

Workshop proposals should include a maximum **400-word abstract**, and the names and affiliations of the organizer(s) and the persons taking part in the workshop.

### Conditions/requirements

Applicants may be the lead presenter of only one paper in the conference. In addition, applicants may chair only one panel. The **deadline for submitting proposals is December 1, 2018 (24:00 CET)**. All submissions should be made online via [www.imiscoe.org](http://www.imiscoe.org). Applicants will be informed about acceptance of their submission by the end of January, 2019.

### Conference fee

For registration before May 1, 2019 (24:00 CET), the fee is € 200 for senior researchers, and € 150 for PhD students. After May 1, 2019, the fee is € 250. The conference rates include conference documentation, admissions to all sessions, admissions to opening and closing plenaries with welcome and farewell receptions, lunches, tea/coffee served during conference breaks. Accommodation is not covered by the conference fee. The fee also includes a one-year individual membership of IMISCOE, which provides members with various benefits.
