### Call for Contributions

We live in an increasingly mobile world: People, imaginaries, knowledges, objects, and capital are on the move. Fuelled by new technologies and globalisation, they cross political, social, and cultural borders and create global nets of connections. Spatial movements often go along with social mobility of individuals or groups of people, resulting in changes of economic positions and social status. However, not everybody and not everything is spatially or socially mobile. Disconnections and exclusions are created by structural and legal constraints as well as discourses of foreclosure, or norms of sedentary lives.

The Fulda International Autumn School 2022 invites doctoral researchers and Master's students to explore the diversity of (im)mobilities and their interrelation with social justice. From an interdisciplinary perspective, including sociological, political, legal, and intercultural approaches, we will scrutinize

- ↘ forms, drivers and implications of (im)mobilities,
- ↘ patterns of inequality, highlighting the intersections of gender, *race*, and class,
- ↘ political and legal instruments that shape (im)mobility. We are particularly interested in the opportunities and predicaments of social, economic and cultural human rights.

The one-week programme offers different formats of exchange:

- ↘ **Keynotes and lectures** from senior scholars will introduce the participants to the relevant research fields.
- ↘ **Interactive workshops** will provide a platform to bring in your own questions and ideas, to discuss your projects and current research challenges in a creative and supportive atmosphere.
- ↘ **Hybrid format:** We are looking forward to an on-site event, but online participation is equally possible.

### Workshop 1: Human Rights and Mobility – Labour Migration in the European Union

During the Covid-pandemic, precarious labour mobility within the European Union has attracted heightened attention. An EU citizenship grants special legal status in relation to freedom of movement, residence, employment, and access to social benefits. However, it has become evident that EU citizenship does not safeguard mobile workers from precarious working and living conditions. The workshop engages with atypical and precarious labour mobility within the EU and aims to look at how governments, administrations, unions, and workers may shape more equitable mobile working arrangements. We invite contributions from the fields of legal and social sciences.

### Workshop 2: Global Trade and Cooperation in Times of Corona: Old and New Asymmetries?

Despite or precisely because of the disruptions in the global exchange of goods, labour and capital brought about by the Corona pandemic and the war in Ukraine, the EU and other major powers appear urging the conclusion of ever deeper trade agreements. The increasing imposition of trade defence measures on the one hand and efforts aimed at 'securing and enhancing' market access on the other raise numerous questions. Issues at stake include their impact on global and local power asymmetries, inequalities and, by extension, social and economic rights not only but most notably in countries of the Global South.

### Workshop 3: Development and Displacements

Each year, development interventions such as dams, pipelines, or urban infrastructure lead to the displacement of millions of people worldwide. While projects are justified by economic benefits, those who lose their homes and livelihoods risk impoverishment and the disruption of social networks, spiritual connections to lands, and economic activities. The panel seeks to interrogate the nexus of development and displacements and their impact on social, economic, and political mobilities or immobilities. We are particularly interested in original contributions that address issues of minority and indigenous rights in the development processes of these projects.

### Workshop 4: Human Rights for Precarious Migrants on the Local Scale

This workshop will address the access of precarious migrants to social services - such as accommodation and health - with a focus on the local level. Relating to debates of urban citizenship, we will explore the challenges that migrants face, identify local strategies to address the exclusion, analyse different approaches to provision within contrasting legal frameworks, and discuss collaborations between public services and civil society.

### Workshop 5: Refugees and Host Societies – Contested Borders of Rights and Belonging

Providing insights into important discussions from Forced Migration Studies, this panel will explore the interactions between refugees and host societies: How do refugees, states, and civil society negotiate the access to rights and belonging for forced migrants who are often considered temporary guests? How do discourses and practices change through time and in relation to different groups of refugees? The panel will compare the situation of Ukrainian and Syrian refugees – particularly in Europe and Jordan, the second largest host country in the world. However, contributions on other cases are highly welcome!

### Workshop 6: Student Mobility

Over the past years, international students' mobility increased rapidly and is an important part of the global higher education landscape. Semesters or studies abroad shape students' trajectories and open up new experiences, opportunities and challenges. Why are students on the move? How does mobility influence study and everyday life as well as student's aspirations and transitions to the labor market? How do different aspects of mobility – such as educational aspirations and forced migration – intersect? In what way does students' mobility influence the home and host countries?

### Workshop 7: Intersectional Perspectives on (Im)mobilites

Intersectional approaches to social inequality have contributed to and advocated thinking critically about the multidimensional aspects of women's oppression. The workshop explores the contributions of intersectional perspectives to complicate our understanding of gender, race, and class as well as their socio-spatial dimensions. Looking at diverse kinds of social and spatial mobilities – ranging from professional and educational carriers to commuting and international migration – we will ask how both the formal and informal systems of power are deployed, maintained, and reinforced in social structures, policies, and practices.

How universal are global regulative ideas such as Human Rights or democracy? How can we engage productively with the tension between legal universalism and particularism as well as with the critiques of Eurocentrism?

Send us the title, keywords, and an abstract of your contribution (max. 300 words). It should specify the concrete questions and challenges you like to get feedback on – theoretical, methodological, or very practical problems are equally welcome.
- ↘ **CHOOSE YOUR WORKSHOP:**  
Point out which workshop you would like to contribute to. You may name two prioritized options.
- ↘ **WHO ARE YOU?**  
Please provide us with brief biographical information – e.g., your institutional affiliation, MA or PhD status, and disciplinary background.
- ↘ **WHAT IS YOUR MOTIVATION?**  
We are curious - tell us why you would like to participate! 2-3 sentences are sufficient.
- ↘ **CHOOSE A FORMAT:**  
Please indicate whether you would like to participate on site at Fulda University or online.
- ↘ **IN NEED OF A GRANT?**  
Tell us whether you would need funding to participate – there are 10 grants for international participants that cover travel and accommodation costs. If you have other options of funding, please be fair and inform us duly!
